We support a network of 130 schools nationwide, including 70% of public high schools in Fairfax County, VA; Montgomery County, MD; and Washington, DC - and we are on track to reach 95% by the end of 2025. Our budget has grown from \$20,000 at our founding to \$1.5 million for the 2023-24 school year. Thousands of teens participate as regular OMM club members every year, including 1,635 teens in the DC area in the 2022-23 school year. And since our founding, the school-wide events and projects that OMM club members have organized to share mental health resources and combat stigma have benefitted more than 200,000 teens.
